Your guide to our service







The Alcohol and Drug Service is a statewide service that provides treatment to individuals and their families for alcohol, tobacco and other drug issues.

All of our services are free, voluntary and confidential. We work with both adults and young people.

Service overview

We provide a number of programs to help people and their families with alcohol, tobacco and other drug issues.

These include:

- intake and assessment
- case management and coordination of care
- withdrawal management
- relapse prevention
- secondary consultation
- brief intervention
- counselling, group work and therapy
- health promotion, information and community education.

We are located in Launceston, Hobart and Ulverstone with services provided to rural areas.

Our services

Community Team

This is our counselling and treatment service. We provide counselling and therapy to individuals and their families or carers to assist with alcohol and other drug issues.

The Community Team includes our Consultation Liaison Service who help other services by providing advice and information for treating alcohol and other drug issues.

Inpatient Withdrawal

Our inpatient treatment service is a statewide service delivered in the south of the state at St Johns Park, New Town. The service supports all regions of the state, with transport options available.

The withdrawal unit is a nine bed facility that provides a planned medically supervised withdrawal from alcohol and/or other drugs.

Pharmacotherapy

This program is our treatment service for opioid dependence.

We provide a replacement therapy for opioids supported by doctors and case managers.

Pharmacotherapy support is provided in all three regions of Tasmania.

Smoking Cessation Program

This program provides education and support to other health professionals in conducting brief smoking interventions with their consumers to help them to quit.

Support is also provided to patients in hospital settings.
