Home safety checklist

In Australia, injuries are a leading cause of death and disability for children. Many injuries occur in the child's own home. This home safety checklist is a tool to help parents and carers set up a safer home for children. For more information on preventing specific types of injuries to children, please view our safety factsheet listing.
